

Field of application:

This equipment is personal protective equipment-EN1891:1998 type A static rope (low stretch kernmantel rope), and this product is designed to provide protection against the danger of falling from heights. This rope can be used for rope access working positioning ,travel restraint,as well as rescue,caving or canyoning. It can also be used as a working rope or a safety rope.

Note: Type A ropes are more suitable for use in rope access and work positioning than

type B ropes.

If type B ropes are chosen, users should be aware that the level of performance will be less than that of type B; that greater care will be required in protecting against the effects of abrasion, cuts, general wear and tear etc., and than in use gerat care should be taken to minimise the possibility of a fall.

This rope must not be loaded beyond its strength rating nor be used for any purpose other than that for which it is designed. In particular, don't use them for load lifting.

- Your safety is related to the integrity of your equipment.
- 2. Equipment used for work safety in accordance with EN 365 must be inspected by an expert in close observance of the instructions or by the manufacturer itself at least every 12 months and replaced if necessary
- 3. Record the results of the inspection on your PPE inspection form(see form 1); type. model, trade name, identification number, manufacturer contact info, dates: manufacture, purchase, first use, Reason for entry (periodic examination or repair), defects noted, repairs carried out and other relevant information, name and signature of competent person, periodic examination next due date.
- 4. In general. The inspection must include:
- An inspection of the product's general condition: age, integrity, soiling proper composition
- Label inspection: Is the label present? Is the label legible? Is there a CE label? Can you read the Date of MFG? Inspection of all individual parts for mechanical damage, e.g.: tears, rips, nicks,
- abrasion, deformation, ribbing, entangling, crushing. Inspection of all individual parts for thermal or chemical damage, e.g.: melting,
- hardening 5. Before each use visually check the condition of the sheath along the entire length of
- the rope. Make sure there are no cuts, burns, frayed strands, fuzzy areas, or signs of chemicals.
- 6. Carry out a tactile inspection of the core along the entire length of the rope. This allows you to detect areas where the core is damaged (hard spot, mushy area).
- 7. If the equipment has been subject to stress through a fall, it should be withdrawn from use immediately. If you have the slightest doubt, the product must be discarded or may only be used again if an expert has provided written confirmation that it is fit for use after examination.
- 8. During use: It is important to regularly monitor the condition of the product and its connections to the other equipment in the system. Make sure that all items of equipment are correctly positioned with respect to each other.

Compatibility:

- 1. Please ensure that the recommendations for use with other components are maintained: All other components of the working harness must be certified and comply with the relevant standards for PPE
- 2. Use ropes in accordance with EN 1891 must be used in systems in accordance with EN 341 (Descender Devices for Rescue), EN 358 (work positioning safety belt) or EN 363 (Personal Fall Protection Systems), i.e. for various rope-supported work, Please note that the surface of new, unused ropes can by very smooth and slippery. When using devices, please read the manufacturer's information on the respective device.
- 3. Rope devices should be adjusted to the rope diameter.
- 4. Metal parts must not have any burrs or sharp edges that could damage the rope. Any combination of equipment that affects the safe functioning of any single piece of equipment or the entire system puts you at risk too!

Precautions for use:

- 1. Type B ropes have a lower performance level than type A ropes; they are more susceptible to abrasion, cuts, normal wear... It is important to pay greater attention to reducing the potential for falls. Type A ropes are better suited than type B ropes for use in rope access and work positioning.
- 2. To prolong rope life (better sheath/corecohesion), soak it in water for 24 hours prior to first use. This removes lubricants and otherproducts used in manufacturing. Let the ropedry slowly. It will shrink by approximately 5 %(5 m for every 100 m).
- 3. Protected from chemicals, heat, abrasion, ultraviolet light, sharp edges that can

damage your rope.

- 4. Rubbing together of two ropes through karabiners or maillons induces heat which could result in rupture.
- 5. Avoid over-rapid abseiling or lowering which could burn the rope and accelerate sheath wear. The melting temperature of polyamide is 230 °C. This temperature may be attained during very rapid descents
- 6. The temperature in which the rope is used must never exceed 80 °C.
- 7. To clean, rinse the rope with lukewarm water and wipe with a damp cloth. The wet rope should be left to dry before storage. The rope should dry naturally, not near a fire or other heat source.
- 8. To disinfect the rope, you may only use products that have no influence on the synthetic materials used. If you do not comply with these conditions, you put yourself
- 9. A rope swells with use and can shrink in length by up to 15 %. Regularly check the lenath of your rope.
- 10. A wet or icv rope is less abrasion-resistant. It is also harder to control in belay/rappel devices.
- 11. A knot at the end of the rope is a necessary precaution in a variety of situations (long rappel, poor visibility, fatique...), Avoid descending too rapidly: risk of burns and accelerated wear of the rope.





Fig.1 Detail of figure of eight knot

- 12. To make a termination, tie a figure-eight knot at the desired location on the rope. We recommend a figure eight loop for your own rope terminations. There must be at least 10 cm of rope behind the knot. Please tie the knot correctly, as illustrated in Fig.1! Please note the route the load-bearing portion of rope takes (arrow). A different version will reduce the breaking load considerably.

- 13. If free climbing is necessary when using the rope during rope-supported work, rescuing or speleology, you must use suitable ropes (e.g. dynamic mountaineering ropes in accordance with EN 892).
- 14. The system must include a reliable anchoring point (in accordance with EN 795,especially 12KN minimum strength) above the user. Avoid slack in any kernmantle rope with limited elongation between the user and the reliable anchoring point.
- 15. If a rope is cut into several lengths, mark the ends with the correct lengths and end-markings. The new lengths of rope must each be furnished with a copy of the Instructions for Use.

You should therefore never load a termination loop transversely (2 carabiners in a loop). Check the load on the rope in the selected configuration and never overload it. We recommend a safety factor of ≥ 7 .
- 6. Make sure that the anchor point is correctly positioned, in order to limit the risk and the length of a fall.
- 7. A fall arrest harness is the only device allowable for supporting the body in a fall
- 8. The Instructions for Use for each item of equipment used in conjunction with this product must be followed.




图1 八结图细节








Fig.1 Detail of figure of eight knot






Fig.1 Detail of figure of eight knot





Fig.1 Detail of figure of eight knot





Fig.1 Detail of figure of eight knot






图1 八结图细节





Fig.1 Detail of figure of eight knot




Fig.1 Detail of figure of eight knot


